Constanța–Danube–Europe: A Two-Way Green Corridor

Current Cargo Flows Along the Danube Corridor:

🚎 Downstream (to Constanța / Black Sea):

Grains & Agricultural Products: Major volumes from Romania, Hungary, Serbia, and even Ukraine moved by barge to Constanța for export. This is one of the **largest IWT cargo segments** on the Danube.

Scrap Metals & Raw Materials: From Central Europe to Black Sea destinations. Fertilizers: Transit cargo to overseas markets via Constanța.

🚎 Upstream (from Constanța to Central Europe):

Fuels & Petroleum Products: Transported to Romania, Serbia, and Austria. **Iron & Steel Products**: From maritime imports, transshipped at Constanța, delivered to Danube countries.

Minerals & Construction Materials: Bulk cargo delivered to construction and industry hubs inland.

Limited container flows: Still in pilot phase; high potential for scaling up multimodal services.





Opportunities for the Future

• **Develop Constanța as a Danube–Maritime Intermodal Hub** - Pro Danube supports cross-border projects and public-private cooperation to enhance Constanța's role as a smart logistics gateway for Türkiye and the Danube region.

• **Upgrade Inland Terminals** (e.g. Ruse, Giurgiu, Budapest, Linz)We work with terminal operators and logistics stakeholders to promote funding access, digitalization, and intermodal development through EU programmes (e.g. CEF, Interreg).

• Improve Fairway Conditions and Navigation Reliability - Pro Danube actively advocates for coordinated river maintenance, infrastructure modernization, and harmonized river information services (RIS) across Danube countries.

• Encourage Modal Shift from Road to IWT - Through awareness campaigns and collaboration with shippers, we promote the economic and environmental benefits of inland waterway transport as a viable alternative.

• Harmonize Digital and Customs Systems - We contribute to digital corridor initiatives to enable real-time cargo tracking, reduce border delays, and simplify administrative procedures — essential also for Türkiye–EU connectivity.
