# RECOMMENDATIONS FOR ENSURING THE SECURITY OF NAVIGATION ON THE DANUBE

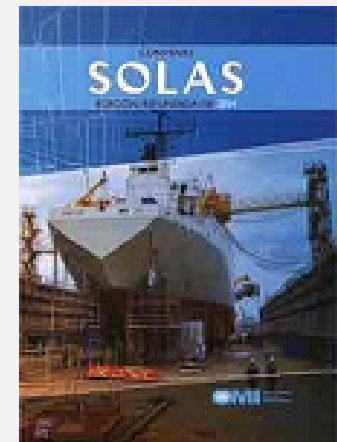
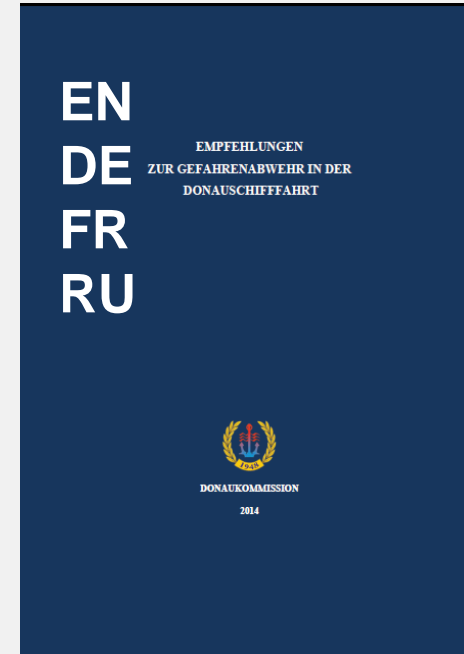
- Adoption: by DC's 83rd session on 10 December 2014
- Entry into force: from 1 January 2015

## THE MAIN OBJECTIVE

Establishment of **general principles** for taking measures preventing consequences related to the **violation of security of vessels** and of port facilities as well as to the unlawful acts against vessels' crews navigating on the Danube

## BACKGROUND

- Proposals by the competent authorities of the DC Member States
- International Convention for the Safety of Life at Sea (SOLAS), 1974: International Code for the security of ships and of port facilities (ISPS-Code)



## SCOPE OF APPLICATION

- navigable sections of the Danube
- Danube's harbour areas



## TARGET GROUP:

- all **competent authorities** responsible for the Danube navigation
- **administrations** of the Danube ports
- **boatmasters** and **other persons** directly or indirectly involved in the Danube navigation

## FUNCTIONAL TASKS

- ON BOARD A VESSEL
- SHIPPING COMPANIES
- PORTS

assessment of **potential threats**

**cooperation** of the DC Member States

appointment of the **officials responsible for security**

development of the **security plans** for vessels and port facilities

**behavioral pattern** of a crew in case of violation of security

special **education and training** for crews

# ASSESSMENT OF POTENTIAL THREATS AND COOPERATION OF DC MEMBER STATES ON SECURITY OF NAVIGATION



- **Information on:**
  - threat of unlawful acts or existence of an incident
  - unsafe navigation areas, cases or threats related to the violation of security to be transmitted to the DC competent authorities
- **Assessment of potential risks**
- **Competent authorities responsible for security of navigation** have to take all necessary measures to eliminate a threat of violation of security of vessels and port facilities
  - in case of incident – to ensure safety conditions for the crew to solve it




## VESSEL SECURITY PLAN

- Plan on board a vessel in international navigation - endorsed by administration of shipping company

### CONTENT:

- identification of restricted-access areas on board and measures to prevent unauthorized access
- measures to prevent unauthorized access on board a vessel
- incident threat or violation of security procedures (behavioral patterns)
- scheme of launch points for vessel alert system
- evacuation procedure
- crew members and personnel of passenger vessel responsible for security
- scheme of incident reports and messages
- data on vessel's, company's officers and competent authorities of the DC Member States responsible for security

## BEHAVIORAL PATTERNS OF CREW IN CASE OF VIOLATION OF SECURITY AND UNLAWFUL ACTS

- Keeping out of **undue risk** → staying **calm**, if possible, → continuing to perform its **duties**  

- Safely **reporting** on violation of security to the **administration** of shipping company  

- In case actions of violators could cause **incident** involving a vessel, trying to **coordinate safe way out** of situation  

- **Freeing** of a vessel from violators → immediate **contact** the **shipping company's officer** responsible for security, → contact the **competent authority** of a state of violation of security,
- *etc.*

- to create a **harmonized system** for common security

### BASIS

- scheme of **coordinated actions** of competent authorities
- principle of **personal responsibility**

- Chapter 1.10 ADN (**security**)
- DC Rules of river surveillance (RS) on the Danube: Information notices issued by RS bodies (**safety**)
